Alcoholic Beverage Awareness Training

(Certified by the State of Nevada Commission on Post-Secondary Education)

Nevada law requires that any County with over 400,000 residents comply with NRS 369 - this now includes **Washoe**.

In short, any owners/operators of a retail liquor store, bar, or “a business that sells alcoholic beverages by the drink for consumption on the premises” or “a business that sells alcoholic beverages in corked or sealed containers or receptacles for consumption off the premises” must have staff (sellers, servers, security guards) complete a **state certified** alcohol awareness program and obtain an “alcohol education card” (valid for 4 years).

Newly hired employees have up to 30 days after being hired to complete their training.

Proceeds from these trainings will be used for alcohol/drug prevention and treatment programs for youth in Washoe County.
